Special Urgent Technical Newsletter TN24.05 – Morco Important Safety Warning – new implications for BSS Examinations of affected boats

We have been contacted by Morco this week requesting further BSS support, with its escalated Important Safety Warning. This is an update and escalation of the Morco alert from earlier this year.

The Warning applies to a list of specific models of open-flued LPG water Heaters. Morco is asking anyone with a listed appliance installed on their boat, to stop using it immediately and isolate or disconnect it from the gas supply.

TN 24.05 (attached) includes additional information for Examiners who may be approached to undertake an Examination on boat with one of the affected appliances fitted, and/or encounter one of these appliances while undertaking an examination. It covers the scenarios of the water heater being connected and working or disconnected and not working.
